## **HOW DOES THE SERVICE WORK?**

Call the service toll free at **1-800-252-9690** or **1-877-9TEXBAR**.

A referral specialist will ask what county you need assistance in and the nature of your concern. The referral specialist will then check to see if we have an attorney listed with our program who services your county and can assist with your type of case.

If there is, you will be asked to provide your name, phone number and mailing address (this information is kept strictly confidential). You will then be given the attorney's name and phone number. It is your responsibility to call the attorney to schedule an initial consultation.

The attorney you are referred to will provide an initial consultation with you of 30 minutes for no more than \$20. If your situation requires work beyond the initial 30 minutes, the attorney's regular fees will apply.

There is no charge for the referral you are provided. However, the lawyers who belong to the service are not free (pro bono) or reduced fee attorneys. The initial consultation of 30 minutes will cost you no more than \$20, payable to the attorney.

You should be in a position to pay a reasonable fee to the attorney you are referred to should they accept your case and you decide to hire him or her.
