I CERTIFY THAT I HAVE A VALID TEXAS DRIVER'S LICENSE OR PERMIT; THAT I DO NOT HOLD A COMMERCIAL DRIVER'S LICENSE (CDL) AT THE TIME OF THE OFFENSE; THAT THE ALLEGED SPEED WAS NOT 25 MPH OR MORE ABOVE THE POSTED LIMIT; THAT MY VIOLATION WAS NOT ISSUED IN A CONSTRUCTION ZONE WITH WORKERS PRESENT; THAT I HAVE NOT TAKEN A COURSE UNDER TRANSPORTATION CODE, SEC. 543.103 WITHIN THE PAST 12 MONTHS AND AM NOT IN THE PROCESS OF TAKING SUCH A COURSE; AND THAT I HAVE NOT COMPLETED A COURSE UNDER TRANSPORTATION CODE, SEC. 543.103 WHICH IS NOT REFLECTED ON MY DRIVING RECORD.

I UNDERSTAND THAT I WILL BE CHARGED COURT COSTS AND A FEE AND THAT THESE FEES ARE NONREFUNDABLE AND MUST BE PAID TO THE COURT BEFORE MY CHARGE WILL BE DISMISSED.

I UNDERSTAND THAT I AM NOT ELIGIBLE FOR THE DRIVING SAFETY COURSE UNLESS I PROVIDE PROOF OF FINANCIAL RESPONSIBILITY AS REQUIRED BY TRANSPORTATION CODE, SEC. 601.051.

I understand that if I hold a provisional driver's license I will be required to be examined by the Texas Department of Public Safety as required by Transportation Code Section 521.161(b)(2) and *return to this court with written proof showing completion of DPS Examination on or before end of deferral period.*
